



EXECUTIVE SUMMARY

Overview

The ARISE Plus ninth six monthly progress report covers the period 8th November 2021 to 7th May 2022. The activities carried out support the ASEAN economic integration effort and are guided by the ASEAN Economic Community Blueprint 2025. ARISE Plus supports 12 Elements and 14 Strategic Measures of the ASEAN Economic Blueprint (AECB) ARISE PLUS also supports 7 priority areas of the ASEAN-EU Plan of Action.

As part of the focused approach adopted for AWP4, and in preparation for AWP 5, 27 major activities were implemented during the reporting period. Substantial effort focused on capacity building and knowledge transfer to strengthen sustainability mechanisms and a total of 34 workshops and events were implemented. These have continued the strong collaboration between the ASEAN Secretariat, relevant sectoral working groups, committees and the EUD Jakarta. The momentum of AEC integration efforts has continued with EU-ASEAN strategic cooperation delivered by ASEAN and ARISE Plus.

Major results during the reporting period

The major results during the reporting period are summarised below. For additional details please refer to Section 1 of the report under the respective activities.


Enhancing private sector engagement and awareness towards greater intra-ASEAN trade

ARISE Plus is dedicated to ensure the ASEAN Trade Repository (ATR) and the ASEAN Solutions for Investments, Services and Trade (ASSIST) platforms are able to meet their true potential in ASEAN. Through close cooperation with ASEAN Member States 5054 NTMs have been validated and uploaded on the ATR platform to date, which will continue to benefit the private sector in terms of regulatory transparency.

Private sector engagement and socialisation is a key strategy adopted by ARISE Plus to ensure businesses are aware and convinced to take full advantage of the platforms that have been developed. Outreach workshops were held for businesses in Brunei Darussalam and Cambodia to increase awareness on the availability, benefits and operation of ASSIST and ATR which included engagement with SMEs and women entrepreneurs.

These outreach events are being complemented with dedicated train-the-trainer (ToT) sessions. The ToT sessions focused on building national capacity in the operation of ASSIST by identifying and training trainers from the private sector in each country. This approach allows for further transfer of knowledge within the country and ensures sustainability of the efforts.

The outreach events organised by ARISE Plus and the anonymity mechanism introduced has resulted in higher usage of the ASSIST platform. Such continuous efforts are in line with *Key Message 3 of the AEC Blueprint 2025 Mid-Term Review (MTR): to embark on broader and more meaningful engagement with the private sector and women entrepreneurs.* These demonstrate the strong and strategic nature of EU-ASEAN collaboration.

Strengthening coordination and coherence across EU ARISE Plus national and regional projects

ARISE Plus (TA Regional) and the EU Delegation to ASEAN have continued to play an important role in facilitating coordination and coherence across the EU ARISE Plus portfolio of nine national projects (covering Cambodia, 2 for Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Thailand, Vietnam) and two regional projects (ARISE Plus TA Regional and ARISE Plus IPR). The project has continued to disseminate flash reports on events. During the reporting period, 17 flash reports were shared amongst the ARISE Plus portfolio of projects and whilst the EU Delegation to ASEAN shared these amongst the EU Delegations across the ASEAN Member States.

A successful Regional Coordination meeting was organised by the ARISE Plus TA Regional and the EUD to ASEAN, on 05 April 2022. The meeting brought together over 30 participants from EU Delegations across the region, the nine national projects and the two regional projects. Projects shared their success stories and this was followed by a synthesis of the technical areas covered by the various projects. The ARISE Plus family of projects is relevant to the ASEAN Economic Community (AEC) Blueprint 2025 across five characteristics (or aspirations) and 22 out of 29 Elements (or sectors of cooperation), making the EU one of the most active dialogue partners of ASEAN.

Strengthening the sustainability of ASEAN food safety systems through a harmonised regulatory regime and enhanced capacities

ARISE Plus is strengthening the sustainability of food safety systems in ASEAN through its efforts in establishing a harmonised regulatory regime, traceability systems and a comprehensive capacity building programme.

Substantial efforts have been placed on developing AMS capacity through the development of training modules, training courses and training workshops for AMS officials to conduct inspections and evaluate food safety systems. These are in accordance with the provision of the MRA for Inspection and Certification Systems on Food Hygiene for Prepared Food Stuff and cover capacity building a range of food safety topics. These topics include how to conduct inspections on food hygiene including prepared foodstuff; food borne disease outbreaks, conducting risk-based inspections, such as profiles of pesticides used on leafy vegetables and food safety sampling; and food safety risk communication The ASEAN Food Safety Regulatory Framework Agreement (AFSRF Agreement) has been finalised and is awaiting formal agreement by the AMS. ARISE Plus has also supported efforts to harmonise the regulatory regime in organic agriculture through an MRA and the associated harmonised certification scheme which are now in their final stages of acceptance by the Experts Group. Other work includes support for the harmonisation of nutrition reference values and the development of specific measures for ceramic food contact materials

Enhancing safety and reliability of pharmaceuticals through a harmonised regulatory regime

ARISE Plus has continued to support the enhancement of safety and reliability of pharmaceuticals through the establishment of a harmonised regulatory regime. The efforts of ARISE Plus over several years, have come to fruition with a final version of the ASEAN Pharmaceutical Regulatory Policy (APRP) which has been endorsed by the Senior Economic and Health officials (SEOM) and SOMHD. The APRP is awaiting adoption by the ASEAN Economic and Health Ministers. The ASEAN Pharmaceutical Regulatory Framework has also progressed substantially and is nearing finalisation with a review being carried out by ASEAN Member States. These regulatory instruments will provide the basis for the legally binding ASEAN Pharmaceutical Regulatory Framework Agreement (APRFA).

ARISE Plus also supported the newly established ASEAN Pharmaceutical Testing Laboratory Committee (APTLC) including the development of their Five-year work plan. The ARISE Plus work in the pharmaceuticals area is characterised by the cross-pillar coordination between the health and economic sectors, which is in line with the recommendation from the AEC Blueprint 2025 MTR for deeper and more meaningful cross-sectoral collaboration.

Partnership building with the private sector for seamless movement of goods in ASEAN through the ASEAN Customs Transit system (ACTS)

In addition to technical training, troubling shooting activities and functional updates, ARISE Plus is committed towards enhancing the uptake of ACTS among private sector stakeholders and to overcome the restrictions brought by the COVID-19 pandemic. In line with this ambition three private sector partnership building events have been organised. These included a joint event for private sector in Malaysia and Singapore, and events for the private sector in Thailand and Vietnam respectively. The events involved over 300 participants from the private sector. Presentations during the events include a testimony from the General Manager of City Zone Express Sdn Bhd who has used and benefited from ACTS and presentations on the end user technical and practical aspects of ACTS that include information such as processes at departure, border and destination, bank guarantee, registration process and challenges faced during the pandemic. Every event included a Q&A session which has always been very interactive and active demonstrating interest among the private sector.

ARISE Plus also organised several on demand follow up workshops to offer further support on ACTS usage, and to address issues and concerns for the country context. Outreach events for Cambodia and Lao PDR are being planned for June and July 2022. Close cooperation between ARISE Plus, the ACTS Central Management Team (CMT) at ASEC and the private sector will ensure the success and sustainability of ACTS.

The private sector partnership building activities for the ACTS are complemented through bi-weekly discussions involving government officials from the six partner ASEAN Member States operating the ACTS, CMT, ASEC Transport and Customs divisions and ARISE Plus in order to resolve issues regarding live ACTS operations. ACTS version 3.3.0, which includes a number of important upgrades, has been successfully installed, tested and deployed in live operating environments across the six ASEAN Member States.

Mainstreaming recommendations from the AEC Blueprint 2025 MTR across ARISE Plus

ARISE Plus, is one of the first ASEAN dialogue partner projects to have successfully mainstreamed a number of recommendations from the AEC Blueprint 2025 Mid-term Review (MTR) across its project components. These include recommendations "R1: strengthen coordination, monitoring and evaluation mechanisms" and "R2: develop consolidated implementation frameworks for cross cutting issues ".

ARISE Plus has adopted a strategy of results-oriented monitoring, reporting, publications, and dissemination to mainstream recommendations R1 and R2. This brings together interrelated elements of analysis, monitoring, learning, reporting, communications and outreach to deliver strategic knowledge products that support decision making. During the reporting phase work has continued on analysis and content for the six-monthly progress report, and other EUD requirements such as EU Bluebook. Results oriented monitoring and measuring of learning outcomes for technical ARISE Plus events has been undertaken through the deployment of 54 online workshop monitoring tools covering pre-training and end of event assessment to support decision making by the project team. A total of 23 event monitoring reports with analysis of participant feedback data have been developed and shared with the project team. To enhance communication and outreach for technical ASEAN events, over 20 communication products and tools have been developed including eFlyers, microsites, slide shows for waiting rooms and exit rooms, and animated presentations. These have been underpinned by key messages and user oriented content to facilitate take-up and buy-in by event participants. Further information is available on:

Monitoring ASEAN digitalisation progress through statistical support

ARISE Plus has continued to support the ASEAN Statistical Community in the monitoring of the digitalisation progress. ARISE Plus has developed various guidance materials, provided cross pillar support, enhanced quality assurance and strengthened skills through trainings to facilitate regional integration of statistical data. Among others one main activity during this reporting period was the follow up phase of training on data collection, monitoring, reporting and dissemination related to the SDG Indicators (SDGIs). This activity will enable ASEAN to monitor its progress towards achieving the 2030 Agenda. Other statistical support provided in the different technical areas will collectively improve the skills and capacity of ASEAN stakeholders especially for CLMV countries in data collection, management and use towards achieving regional digitalisation aims to support further economic development.





SECTION 1 PROGRESS ON PROJECT ACTIVITIES



Component 0: Management and Outreach

Sub Component 0.1 Programme Management and Coordination

A total of 27 major activities were implemented during the reporting period. To gain a visual picture, the key project management indicators are summarised below.




Figure 1: Number of workshops

Substantial efforts were made on capacity building, transferring know-how and creating outreach as part of the sustainability strategy outlined in the AWP4. 34 workshops were conducted during the reporting period which compares favourably to all the previous reporting periods of the project as visualised from the figure 1 below.

13,933.92 Euro of incidentals were used during the reporting period focusing on platforms for online events and the use of translators. The use of online approaches for workshops and training continued the trend of low incidentals usage despite the delivery of a large number of workshops.




Figure 4: Incidentals used

Strengthening coordination and coherence across EU ARISE Plus national and regional projects

ARISE Plus (TA Regional) and the EU Delegation to ASEAN have continued to play an important role in facilitating coordination and coherence across the EU ARISE Plus portfolio of nine national projects (covering Cambodia, 2 for Indonesia, Lao PDR, Malaysia, Myanmar, Philippines, Thailand, Vietnam) and two regional projects (ARISE Plus TA Regional and ARISE Plus IPR). The project has continued to disseminate flash reports on events. During the reporting period, 17 flash reports were shared amongst the ARISE Plus portfolio of projects and whilst the EU Delegation to ASEAN shared these amongst the EU Delegations across the ASEAN Member States.

A successful Regional Coordination meeting was organised by the ARISE Plus TA Regional and the EUD







to ASEAN, on 05 April 2022. The meeting brought together over 30 participants from EU Delegations across the region, the nine national projects and the two regional projects. Projects shared their success stories and this was followed by a synthesis of the technical areas covered by the various projects. The ARISE Plus family of projects is relevant to the ASEAN Economic Community (AEC) Blueprint 2025 across five characteristics (or aspirations) and 22 out of 29 Elements (or sectors of cooperation), making the EU one of the most active dialogue partners of ASEAN

In addition, the Team Leader has engaged in:

- Regular consultation all relevant stakeholders, including high level officials in ASEAN and EU Delegations;
- Provided strategic inputs to the AEC pillar of the ASEAN Secretariat;
- Managed the team of Key and non-Key Experts, including the reviewing of all ToRs for NKE's,
- Monitoring of performance and outputs using internal monitoring tools;
- Reported regularly to the EU Delegation on progress achieved in implementing the programme;
- Participated actively in M&E activities, including corrective action and integration of best practices learnt from the previous years.

Sub Component 0.2 Demand Driven Contingency

The Standards and Conformance division of the ASEAN Secretariat, on behalf of the ASEAN Cosmetics Committee (ACC), requested support from ARISE Plus to provide an update and explain some significant changes that have been made to the Cosmetics regulation in the EU in the last 3 years. Under previous projects namely APRIS 2 and ARISE, support had been provided to the ACC in developing drafting and implementing the ACD which as such is closely aligned to the EU Regulations on Cosmetics. After exchanges with ASEC, ToR were agreed, and a suitable expert identified and contracted to deliver the updates.

Sub Component 0.3 Communications and Outreach

The Team Leader in conjunction with the Key Experts and the backstopping team maintained the visibility of project during this period. Component 1.0: Trade Facilitation and Transparency

Component 1 on Trade Facilitation and Transparency is organized on the basis of three Sub-Components of activities in order to: 1) logically reflect the areas of ARISE Plus intervention mandated under the ToRs; 2) better organize the provision of support in light of the results to be achieved and the needs expressed by ASEAN during the coordination meetings and consultations held within the relevant ASEAN Sectoral Bodies in AWP1, AWP2 and AWP3 (i.e., SEOM, ATF-JCC, CCA, CCS, CCI, the respective AMSs' ASEAN Chairs, ASEC, ABAC, etc.); and 3) leverage on the combined resources of each cluster of activities for purposes of achieving the overall trade facilitation results mandated under ARISE Plus.

Despite the impact of the *Covid-19* pandemic, all activities are largely on course vis-à-vis the Work-Plan objectives and/or the 'on-demand' nature of the support being provided. Once again, particularly noteworthy is the further progress that has been achieved, during the last 6 months of project implementation, both in quantitative and qualitative terms, with respect to the progressive operationalization of the *ASEAN Trade Repository* under Sub-component 1.1. In fact, despite several delays in many countries, which were severely affected by new waves of *Covid-19* infections and lockdowns (*i.e.*, Cambodia, Indonesia, Lao PDR, Malaysia, the Philippines, Thailand and Viet Nam, where the *Omicron* outbreaks greatly slowed down the domestic processes of Government validation of the NTMs), the number of validated non-tariff measures (NTMs) uploaded on the ATR has grown from 4,465 to 5,054, equivalent to a 13% increase. During this semester, 2 new cases were filed under the system of *ASEAN Solutions for Investment, Services and Trade* (ASSIST), making it a total of 14 in the last 12 months period (*i.e.*, 50% of the 28 cases filed in total since August 2016) and a sign that the increased outreach and awareness creation efforts are showing positive outcomes.

Going forward, Component 1 shall continue to follow the planned support and focus will be placed on the progressive implementation of the ATR (*i.e.*, the completion of all the first four Categories of the ATR's trade-related regulatory transparency is foreseen for the end of 2022, as per the AMSs' determinations within the ATF-JCC and SEOM), on continuing to support private sector engagement (*i.e.*, outreach and awareness creation on the ATR and ASSIST, as well as the full implementation of the Roundtable Discussions on Trade Facilitation through dedicated webinars on issues of relevance to the updating of the ATIGA), and on continuing the high-level legal support to AMSs and the ASEAN Secretariat (*'on demand'*) vis-à-vis the crucial process of General Review of the ATIGA and emerging topics for negotiation by ASEAN in its FTAs with trading partners. *'On demand'* activities shall also remain available to ASEAN with respect to ASSIST (primarily outreach activities and IT and operational support of the ASEAN Secretariat), strengthening NTM notifications to comply with Article 11 of the ATIGA, and the appropriate tools to address outstanding NTMs cases under the Matrix of Actual Cases (MAC), as well as for purposes of streamlining NTMs in light of the post-*Covid19* Recovery Framework.

In light of the progressive lifting of restrictions within the ASEAN region, it does not appear that the *Covid-19* pandemic will significantly slow down or prevent the implementation of any activity under Component 1 and the expectation is that considerable progress can be achieved during the next six months and ahead of Project completion, especially vis-à-vis the progressive operationalization of the



ATR and the focus on its sustainability in the medium/long-term.

Expected outcome: Enhancing trade-related regulatory transparency in ASEAN

The objective remained the gathering of all relevant NTMs in the ATR sub-categories of SPS and TBT measures, as well as other non-SPS and non-TBT NTM sub-categories, in order to properly classify them, 'package' them for upload onto the ATR, verify them within ARISE Plus, submit them to the respective AMSs' authorities for validation, and upload them onto the ATR by web-linking them to the NTR and/or to the available national online databases. Work was conducted in Cambodia, Indonesia, Lao PDR, Malaysia, the Philippines, Thailand and Viet Nam (*Brunei Darussalam and Singapore are no longer recipients of technical assistance by ARISE Plus with respect to this area of intervention).

Status: Ongoing

 Held a series of ATR Outreach Events (in combination with ASSIST Outreach Events and ASSIST Train-the-Trainers Workshops) to the benefit of the private sector in 2 AMSs, particularly catering to SMEs and to women entrepreneurs within the ASEAN Women Entrepreneurs Network (AWEN). These events were held in Brunei Darussalam on 15 March 2022 and in Cambodia on 4 April 2022.

Status: Ongoing





Outputs Delivered

- Interim Reports and/or Final Reports (depending on the individual SNKE's ToRs), containing the detailed account of all work conducted during the semester by the SNKEs in relation to the SPS, TBT and non-SPS/non-TBT NTM sub-categories that were identified, collected, classified and 'packaged' in the respective AMSs, for verification by ARISE Plus, validation by AMSs and subsequent upload by AMSs on the ATR under the subcategories on SPS (4.1), TBT (4.2) and non-SPS/TBT NTM (4.3 to 4.15), have been produced in either Word files or Excel spreadsheets.
- In order mitigate the impact of the Covid-19 pandemic, the SNKEs continued to hold webinars with the relevant AMSs' ATR/NTR Focal Points and competent authorities in most countries, with a number of in-person meetings already implemented, where allowed by the prevailing local regulations. Despite several delays in many AMSs, which were severely affected by new waves of Covid-19 infections and lockdowns (i.e., Cambodia, Indonesia, Lao PDR, Malaysia, the Philippines, Thailand and Viet Nam, where the Omicron outbreaks severely impacted the ability of Government authorities to gather and to engage in the processes of validation of the packaged NTMs), the number of validated non-tariff measures (NTMs) uploaded on the ATR has still grown from 4,465 to 5,054, equivalent to a 13% increase. Most importantly, the ATR category of SPS measures is now fully completed for all AMSs, while the category of TBT measures is largely completed (only a handful of NTMs remain to be validated and uploaded on the ATR by the Philippines, while Brunei Darussalam has completed the internal processes but not yet uploaded the measures on the ATR). Importantly, Indonesia and Singapore have already completed their work vis-à-vis all the first 4 categories of ATR transparency.

Problems Encountered

Besides the continuing complexity of the task at hand, the biggest hurdle during the last semester has been the ability to systematically engage with the relevant governmental stakeholders for purposes of validating the 'packaged' NTMs, largely as a consequence of the new waves of Covid-19 infections and lockdowns in the respective countries during the *Omicron* outbreaks, but also for lack of ownership. Overall, the ATR/NTR-related work keeps suffering from a general lack of inter-ministerial coordination and delays for the unavailability of line agencies to meet and timely advance the identification and classification work. A significant number of verified and properly-packaged measures (i.e., 1,775 NTMs) await validation and could be uploaded relatively quickly onto the ATR, thereby moving closer to full operationalisation, if AMSs invested more resources in this ATIGA obligation. This is an area where the ability of ARISE Plus Regional to build institutional capacity is limited, but greater synergies with the ARISE Plus National Programmes are being discussed, particularly for purposes of guaranteeing the medium/long-term sustainability to the ATR and the respective NTRs.

Overall Result to- date

 Consistent increase in the degree of ASEAN trade-related legislative and regulatory transparency, in line with Article 13 of the ATIGA. The process of identification, classification and 'packaging' of the respective AMSs' NTMs for upload on the ATR is:

<u>Categories 1, 2 and 3</u>: Completed in Indonesia and Singapore;

<u>Sub-Category 4 - SPS</u>: Completed in all AMSs;

<u>Sub-Category 4 - TBT</u>: Completed in all AMSs, with the exception of Brunei Darussalam and the Philippines, where they are very advanced and being finalised; and

<u>Sub-Category 4 - Non-SPS/Non-TBT</u>: Completed in Indonesia, Singapore and Viet Nam; Advanced in Cambodia, Lao PDR, Malaysia and Myanmar; and Delayed in Brunei Darussalam, Philippines and Thailand.



Component 2.0: Standards and Conformity Assessment in Particular Healthcare and Agrobased Product

Component 2 on Standards and Conformity Assessment deals with generic issues on standardisation with a focus on the agro-food and pharmaceutical sectors. The Sub-Components accordingly deal with conformity assessment, harmonisation of standards, food safety, organic agriculture and pharmaceuticals. Support is provided to the relevant ASEAN counterpart sectoral bodies. These include the ACCSQ oversees all of standards and conformity assessment, its working groups and product working groups; WG 1 on Standards, WG 2 on Conformity assessment and accreditation, Prepared Food Foodstuffs WG and the Pharmaceutical Product WG. Other counters include Health sector Bodies; Health Cluster 4 on food safety, and the & ASEAN Health Cluster 3 on the pharmaceutical sector. Experts Working Group on Organic Agriculture is the main counterpart in the development of the Organic Agriculture MRA. The support provided has been aligned with the respective work plans of the ASEAN bodies as reflected in the ARISE Plus AWP 3 & 4.

The travel restrictions from the *Covid-19* pandemic did not materially reduce the support but did slow the progress with a few exceptions. The ASEAN secretariat and the Member States representatives have become accustomed to working on-line and this has resulted in implementation of a substantial number of workshops, consultations and training events, held virtually during the reporting period.

The significant developments on the various Sub-Components are:

<u>Subcomponent 2.1:</u> WG 2 accepted ARISE Plus proposal for the development of an *Guidelines for Implementation of Harmonised Accreditation in ASEAN* Member States and work on this has started. This guideline is aimed at advancing the use of accreditation as a basis for mutual recognition across the sectors that ACCSQ covers.

<u>Subcomponent 2.2:</u> WG 1 is nearing the adoption of a revised process for the harmonisation of standards. This is the culmination of several rounds of discussions led by ARISE Plus and will lead to clarity and common understanding aimed at proving a means to ASEAN to strengthen and increase pace of harmonisation of standards.

<u>Subcomponent 2.3:</u> Progress under this component has been made on preparation for implementation of the

Mutual Recognition Arrangement for Inspection and Certification Systems on Food Hygiene for Prepared Food Stuff (MRA on PF) Under the purview of ACCSQ PFPWG, where ARISE Plus has completed training of experts who will conduct inspections and evaluate Member States' food safety systems under the provisions of the MRA. The support continued to be provided for the Mutual Recognition arrangement on Organic Agriculture under the purview of SOMAMAF Experts Working Group for Organic Agriculture This MRA and the associated harmonised certification scheme is now in its final stages of acceptance by the Experts Group. Training has been provided to Member States Officials on conducting inspections on Food Hygiene, Food Borne Disease Outbreaks and on the conducting Risk Based Inspections under the purview of SOMHD ASEAN Health Cluster 4 food safety.





Other supporting work included support on the harmonisation of nutrition reference values and the development of specific measures for ceramic food contact materials under the purview of ACCSQ PFPWG.

<u>Subcomponent 2.4</u> The most significant development in the sector is the progress made in the ASEAN Pharmaceutical Regulatory Policy (APRP). ARISE Plus supported a series of intensive discussions between Members of PPWG and AHC 3 and this has resulted in a final version that had been endorsed by SEOM and SOMHD, while awaiting adoption by AEM and AHMM. The ASEAN Pharmaceutical Regulatory Framework document has been developed in parallel is currently near finalisation and being reviewed by Member States. These documents will provide a basis for drafting of a legally binding ASEAN Pharmaceutical Regulatory Framework Agreement (APRFA). Support was additionally provided to the newly established ASEAN Pharmaceutical Testing Laboratory Committee (APTLC) and in the development of the Committees 5-year work plan.

Component 3.0: Customs, Transport and ACTS

ASEAN has continued to pursue its regional economic integration agenda with significant progress over the past years. The commitments made by the ASEAN leaders are expressed collectively in the AEC Blueprints 2015 and 2025, the Master Plan on ASEAN Connectivity 2025 and the ASEAN Trade in Goods Agreement (ATIGA). Commitments related to Customs and Transport are set out in the ASEAN Agreement on Customs (2012), the ASEAN Customs Vision 2015, the ASEAN Framework Agreement on the Facilitation of Goods in Transit (AFAFGIT) and the Protocol governing the implementation of the ASEAN Harmonised Tariff Nomenclature.

One of the key objectives of the AEC Blueprint 2025 is the progressive reduction or elimination of border and behind-the-border regulatory barriers that impede trade, to achieve the competitive, efficient, and seamless movement of goods within the region.

The planned interventions for Component 3 of the ARISE Plus Terms of reference (ToR) fall into three broad areas, Transport, Customs and ACTS and as such are reflected in the support activities carried out by ARISE Plus.

Under Transport, the activities have assisted the removal of barriers to the free flow of goods by supporting implementation of the ASEAN Framework Agreement on the Facilitation of Goods in Transit (AFAFGIT) and ASEAN Framework Agreement on the Facilitation of Inter-State Transport (AFAFIST). Support has also been provided in implementation of the ASEAN Framework Agreement on Multi- Modal Transport (AFAMT).

Under Customs, support has been provided on demand to assist the development of an integrated Customs environment for the trading community. However, the advent of the virus pandemic has interrupted many of these activities, as face to face seminars are required in order to make genuine progress, and these are not possible when the virus is endemic in the region.

Under ACTS the focus of the activities has been to support the live operations of ACTS, which has been successfully installed along the north-south and east-west transit transport corridors of ASEAN, involving Malaysia, Singapore and Thailand (MST) and Cambodia, Lao PDR, and Vietnam (CLV) respectively. Resources have been committed for management and training required to ensure for the long-term sustainability of the ASEAN Customs Transit System (ACTS) in the region. Further AMS engagement is being pursued by a series of bi-weekly virtual ACTS conferences involving Customs and Transport Authorities, and the private sector operatives. Additional private sector outreach events are planned, in order to increase the number of movements carried out under ACTS.

Expected outcome: Enhanced harmonisation of the customs, transport and logistics systems in ASEAN.

Problems encountered	The COVID-19 pandemic delayed ACTS Implementation and uptake by private sector. Tasks status (ongoing, completed)

- PMS were supported on technical ACTS issues in the ICT environments via email and/or conference calls by the project's ACTS IT Team.
 Malaysia benefited from on-site support by the Malaysia-based ACTS IT Team member however this was limited by COVID-19 restrictions.
- ACTS version 3.3.0 has been successfully installed, tested by the PMS and deployed in live environments in PMS. It is successfully being used by the private sector in conducting regular ACTS live movements.
- ARISE Plus has provided Vietnam with significant on-site support with their ACTS ICT environment and applications, including completed upgrade to ACTS 3.3.0.
- Helpdesk and corrective maintenance services were provided to PMS to ensure business continuity of ACTS, all bugs identified were fixed, tested by ARISE Plus and will be included in next major ACTS 3.4.0 software release.
- 13 ACTS change requests agreed by SWG-ACTS and approved by ACTS Change Management Board (CMB) are now being included in ACTS 3.4.0 software release, which is planned for July 2022 delivery.
- Additional 4 change requests were agreed by SWG-ACTS and approved by ACTS Change Management Board (CMB) and will be included in the software release ACTS 3.5.0.
- The Scope of two additional ACTS IT subsystems and other big functionality additions were finalized in three 3-day ACTS analysis meetings with relevant stakeholders in the transport and Customs sectors, including representatives of SWG-ACTS and TFWG:
 - Transport Monitoring System (TMS) for management of ASEAN Goods Vehicle Cross-Border Permits (AGVCBPs) and monitoring of the movements of trucks used in ACTS in ASEAN region.
 - Online Trader Registration (OTR) system allowing traders to apply for registration in ACTS, ATT status, and simplifications available for ATTs, online.
 - Dashboard for ACTS National Transit Application (NTA) that will simplify day to day work for Customs officers involved in processing of ACTS movements.





Activity 3.3.5 Carrying Out a Functional Upgrade of the ACTS

- Automated collection of additional statistics on ACTS movements.
- Detailed System Requirements Specifications (SRS), Business Process Specifications (BPS) and Software Architecture Documents (SAD) were produced by ARISE Plus, reviewed and approved by AMS. Based on these documents, the new systems (TMS and OTR) are currently in development and targeted to be delivered in July 2022 as part of the ACTS 3.4.0 software release.

Status: Ongoing

Outputs delivered

- ACTS 3.3.0 software release was deployed and now in live operations in Vietnam along with the other 5 PMS.
- All corrective issues relating to software bugs identified during live operations and testing performed on the system were resolved and fixes are being prepared to be included in ACTS 3.4.0 software release.
- 13 ACTS change requests are being implemented in ACTS 3.4.0 software release, which is planned for July 2022 delivery.
- 4 additional ACTS change requests were agreed by SWG-ACTS and approved by ACTS Change Management Board (CMB).
- Scope of two additional ACTS IT subsystems and other big functionality additions were finalized in three 3-day ACTS analysis meetings. Detailed specifications of the two additional ACTS IT subsystems, TMS and OTR, were finalized in January 2022 and the systems are now being developed by ARISE Plus.

Problems encountered

Generally, very few problems other than delays caused by COVID-19 pandemic were encountered in this activity. Despite the delays, the activity progressed well with good cooperation from ASEAN Member States and professional functional upgrade development by the ACTS IT Team.

ACTS software enhancements delivery schedule and scope has been adjusted to allow for the delays in the finalization of the specifications documentation of the Transport Management System (TMS) and Online Trader Registration System (OTR). Final version of specifications documentation of the two new ACTS sub-systems were approved on 14 January 2022.

In summary, the delays and necessary rescheduling of the deliveries are due to:

 Delays in conducting the ACTS Analysis Meetings due to national Covid-19 restrictions in PMS.





Activity 3.3.5 Carrying Out a Functional Upgrade of the ACTS

- Increased scope of the Transport Management System (TMS) and Online Trader Registration (OTR) system as a result of deliberations in the three ACTS Analysis Meetings.
- Increased scope of the Dashboard functionality and introduction of additional statistics into the list of automatically collected statistics of ACTS.
- Increased number of CRs (17) approved by SWG-ACTS and ACTS-CMB.
- Significant delays and the resulting increased effort required to deploy and roll out ACTS 3.3.0 version remotely in 5 PMS and onsite in Vietnam due to unprecedented arrangements that needed to be made by PMS and ARISE Plus.
- Anticipation of the effort and time required for user acceptance testing, deployments and roll outs of new ACTS versions 3.4.0 and 3.5.0 in ACTS ICT environments in 5 PMS remotely and Vietnam onsite.

Lessons learnt

Having suitable ICT experts in the ACTS IT Team from the region at national and regional levels has been essential to ensure sustainability of ACTS operations and future system resilience.

Overall result todate

ACTS functionality has now been enhanced as per scope of ACTS 3.3.0 software release and is in live operations in all PMS used by the ACTS Principal Traders in their regular weekly live ACTS movements. With the additional changes agreed by AMS that will be included in ACTS 3.4.0 and ACTS 3.5.0 software releases, the functionality, user-friendliness and efficiency of ACTS will be further enhanced.





Component 4.0: ASEAN Economic Integration Monitoring and Statistics

Expected outcome: Strengthened results-based management and evidence-based decision making in the ASEAN integration process.

Sub-component 4.1 ASEAN Economic Integration Monitoring

The EU has been one of the most significant dialogue partners of ASEAN to have supported ASEAN Economic Community (AEC) integration efforts through ARISE Plus. Since November 2017, ARISE Plus has supported AEC integration efforts across 12 AEC elements (or sectors of integration) and 14 strategic measures of the AEC Blueprint 2025.

This subcomponent focuses on monitoring the substantial support provided by the EU through ARISE Plus towards AEC integration efforts, supporting ASEAN Secretariat and ASEAN Sectoral bodies in strategic decision making through provision of high-quality analysis, monitoring and evaluation, strategic publications and increasing wider awareness of AEC integration efforts and EU support for this process.

Activity 4.1.1 has continued its evolution to a more strategic activity focusing on results-oriented monitoring, reporting, publications, and dissemination. This reflects the progress made by ARISE Plus since November 2017 and the added-value of bringing together interrelated elements of analysis, monitoring, learning, reporting, communications and outreach to deliver strategic knowledge products that support decision making. During the reporting phase work has continued on analysis and content for the six-monthly progress report, for EUD requirements such as, EU Bluebook. Results oriented monitoring and measuring of learning outcomes for technical ARISE Plus events has been undertaken through the deployment of interactive tools across all project components. This has supported decision making by the team both during events and post-event. To enhance communication and outreach for technical ASEAN events, several communication products and tools have been developed including eFlyers, microsites, slide shows for waiting rooms and exit rooms, and animated presentations. These have been underpinned by key messages and user oriented content to facilitate take-up and buy-in by event participants. This is part of the ARISE Plus results oriented and sustainability strategy reflected in the AWP4 and incorporates findings from the AEC Blueprint 2025 Mid-term Review (MTR) across all project components including project management.

Activity 4.1.2 builds on the recommendations of the Mid-Term Review (MTR) of the report of the AEC Blueprint 2025, which was conducted during AWP3. Work during the reporting period focussed on identifying priority areas to operationalise key findings from the MTR including results-based management and planning amongst ASEC desk officers and sectoral bodies. During AWP5, activity 4.1.3 will be subsumed under 4.1.2.





Activity 4.1.1 Results oriented monitoring, publications and dissemination for ARISE Plus



Support for Sub-Component 4.2 aims to strengthen coordinating role of the ASEAN Community Statistical System (ACSS) for improved statistical quality as well as production capacities to be able cater for relevant new data requests from ASEAN Sectoral Bodies. Sub-Component 4.2 deals with fostering harmonisation of key regional integration statistics such as international merchandise trade statistics (IMTS), system of national accounts (SNA), and Balance of Payments Statistics - covering statistics on international trade in services (SITS) and foreign direct investment statistics (FDIS). Of equally important are the support for monitoring of the sustainable development goals indicators (SDGI), monitoring the implementation of the ACSS Code of Practices (CoP), enhancing statistical dissemination and communication and cross-pillar activities. Emphasis was on activities which lead to sustainability, notable impact and visibility.

While some delays were experienced during the first year of the COVID-19 pandemic, more activities and achievements were realized in 2021/2022, as the ability to adapt to the barriers of online support improved. Below are the significant developments under sub-component 4.2.

Strengthened Supporting Mechanism and instruments for harmonisation of statistics

- The followings have been developed to guide AMS in pursuing its development in the respective domains of statistics in a more concerted and sustainable way:
 - SITS Methodological Review and Guide, MRG (or Compilation Guide) for use in benchmarking the existing SITS methodologies in each AMS.







- FDIS Issues-Centring Work Plan (country-wise work plan for addressing specific issues/priority topics).
- SNA Operational Guides,
- IMTS Compiler Handbook.
- ASEAN Harmonised Tariff Nomenclature (AHTN2022) conversion table, established in 2021, will enable the construction of a series of comparable IMTS data from 2022 and backward and support other cross-sectoral analysis.
- The cross-pillars support, to help ensure sustainability and harmonisation of statistics includes, amongst others:
 - Metadata (currently for social indicators and SNA indicators) established in 2021 for helping ensure harmonisation of statistics.
 - CoP quality measures/indicators which are now available for all ACSS working groups and ASEANStats, for use in monitoring the implementation of the CoP.
 - Support for the implementation of an ASEAN-Help-ASEAN Framework (AHAF) and support for Lead-Country practice.
 - Support for strengthening ASEANStats and ACSS Strategic Plan, to help foster AHAF support and strengthen the ACSS coordination.
 - Successful implementation of 13 AHAF activities implemented in 2021 from all working groups with practically no direct support from ARISE Plus and another 9 activities planned for 2022 were reported by ASEANStats to the SCPC23.

Enhanced quality assurance and production of harmonised statistics

- Baseline quality reports are now available under some ACSS working groups, prepared based on the country's assessment of the implementation of CoP.
- The successful migration of the data processing tools to Eurotrace in Lao PDR, Cambodia, and ASEANStats has led to improved IMTS data credibility and consistency and more timely submission of IMTS data to ASEANStats.
- More breakdowns of SITS as well as FDIS data are now available.
- IMTS data by mode of transport are now available for immediate dissemination.
- ASEAN SDGI data series 2016-2020 are now under review, for dissemination by August 2022, following the successful online dissemination of the SDGI Baseline Report 2020.

Strengthened skills in analysis, dissemination and communication, and enhanced visibility

- ARISE Plus provided moderate support for the initiation of the ACSS open data assessment back in 2019. The ACSS Open Data is now regularly assessed, providing positive impacts on statistical dissemination and communication.
- Through two training on video-graphics, the AMS and ASEANStats are now capable of producing video-graphics presentations.
- The statistical analysis skills were strengthened following the training on data estimation and missing data imputations.
- ASEAN SDGI Snapshot publication is in progress, following the successful online dissemination of the SDGI Baseline Report 2020.
- The social media training held recently, is expected to enhanced visibility of statistics and the institution as well as user engagement.





• Support for ACSS-level coordination and visibility, such as the ACSS High-level Forum conducted back-to-back with the ACSS10.

SECTION 2 INTERNAL MONITORING ASESSMENT

This section provides an internal monitoring assessment of the ARISE Plus programme since the commencement of the programme. The internal assessment focusses on core assessment criteria of relevance, partnerships, efficiency and effectiveness in line with the Monitoring Strategy of the programme. The analysis covers the programme from its inception on 8th November 2017 until 7th May 2022. The monitoring analysis provides aggregate data and in selected areas it provides a breakdown by reporting period.

Relevance

ARISE PLUS has had a strong level of relevance to the needs and priorities of its stakeholders, namely the ASEAN Secretariat, the ASEAN Member States (AMS) and the European Union (EU). The relevance of ARISE Plus has manifested itself through the strategic support it provides to 12 Elements and 14 Strategic Measures of the ASEAN Economic Blueprint (AECB) and 38 Key Action Lines of the ASEAN Consolidated Strategic Action Plan (CSAP). ARISE PLUS also supports 7 priority areas of the ASEAN-EU Plan of Action and 5 Sustainable Development Goals. These can be visualised from figure 1.

Partnerships




Figure 3: ASEC Divisions engaged¹




Figure 4: overview of types of AMS Ministries and agencies engaged

Efficiency

Availability and utilisation of resources




Figure 5: expert days used (by reporting period)

A total of 3,674² key expert (KE) days, 10,638 senior non-key expert (SNKE) days and 204 junior non-key expert (JNKE) days have been used since programme commencement until end of April 2022. Over 229 non-key expert (NKE) assignments have been contracted and 2,129,715 Euros of incidentals utilised. The utilisation of resources can be visualised from figures 5 and 6 by reporting period.

During the current reporting period, the usage of incidentals was largely due to translation of materials and use of platforms for ASEAN events and workshops which were held online.

Activities Implemented




Figure 7: activities implemented by reporting period

Resources used have resulted in the implementation of a total of 27 major activities during the reporting period with a focus on less activities as part of the strategy of AWP4. The number of activities implemented during each successive reporting period can be visualised from figure 7.




Figure 8: number of regional and national workshops by reporting period





Figure 10: number of ARISE PLUS workshops hosted by AMS (from inception)

As illustrated in figure 10, ARISE PLUS workshops were hosted by all AMS demonstrating the strong ownership of the programme amongst AMS. ARISE Plus has facilitated all 181 workshops whilst directing hosting 65 workshops through virtual means.




Figure 12: breakdown of workshop participants by gender

In terms of gender, ARISE PLUS workshops have had a strong gender mainstreaming in terms of participants during each of the reporting periods as visualised from figure 12. A total of 4,741 female participants and 4,000 male participants have attended ARISE PLUS workshops since commencement. There has been a substantial increase in the proportion of female participants during the past two reporting periods due to concerted efforts by ARISE Plus to engage stakeholders and women's business networks, such as AWEN and women's groups in the AMS.
